1 INTRODUCTION

1.1 DECLARATION OF PECUNIARY INTERESTS, SIGNIFICANT NON-PECUNIARY INTERESTS AND LESS THAN SIGNIFICANT NON-PECUNIARY INTERESTS

The provisions of Chapter 14 of the Local Government Act, 1993 (the Act) regulate the way in which Councillors and designated staff of Council conduct themselves to ensure that there is no conflict between their private interests and their public role.

The Act prescribes that where a member of Council (or a Committee of Council) has a direct or indirect financial (pecuniary) interest in a matter to be considered at a meeting of the Council (or Committee), that interest must be disclosed as soon as practicable after the start of the meeting and the reasons given for declaring such interest.

As members are aware, the provisions of the Local Government Act restrict any member who has declared a pecuniary interest in any matter from participating in the discussion or voting on that matter, and requires that member to vacate the Chamber.

Council's Code of Conduct provides that if members have a non-pecuniary conflict of interest, the nature of the conflict must be disclosed. The Code of Conduct also provides for a number of ways in which a member may manage non pecuniary conflicts of interest.

It is recommended that Committee Members now disclose any conflicts of interest in matters under consideration by the Employment and Economic Development Policy Committee at this meeting.

3.1 UPDATE ON USHIKU, JAPAN

The annual Japanese Speaking Contest will be held 1 December. The event will be held in the Orange Regional Gallery from 4pm.

An exchange visit to Orange is being planned for 26th of Feb to 13th of March, next year when 20 students and 3 teachers from Ushiku Eishin High School will visit Orange. A civic reception is being planned for Tuesday 28th February.

Ushiku City Council are continuing to plan for a visit by the Mayor and a number of local citizens to Orange next year. They have looked at a number of alternative dates in recent months. The latest dates are May 12 to May 16, 2023.

Cr Mel McDonnell brought a motion to the 23 September meeting. The background information provided to the meeting stated that:

In February this year, Russian forces invaded Ukraine. Since then, 13,212 civilians have been killed or injured (more than 5,500 fatalities and more than 7,600 people injured).

It has resulted in the largest refugee crisis since the Second World War. More than 3.4 million Ukrainians have fled the country.

Orange City Council currently has Sister City relationships with 4 cities. Given the Ukrainian people are in the midst of a war, establishing a Sister City relationship is not appropriate. However, by selecting a Ukrainian city for a Friendship City Orange City Council can demonstrate our ongoing support for the people of the Ukraine.
