1 INTRODUCTION

1.1 DECLARATION OF PECUNIARY INTERESTS, SIGNIFICANT NON-PECUNIARY INTERESTS AND LESS THAN SIGNIFICANT NON-PECUNIARY INTERESTS

The provisions of Chapter 14 of the Local Government Act, 1993 (the Act) regulate the way in which Councillors and designated staff of Council conduct themselves to ensure that there is no conflict between their private interests and their public role.

The Act prescribes that where a member of Council (or a Committee of Council) has a direct or indirect financial (pecuniary) interest in a matter to be considered at a meeting of the Council (or Committee), that interest must be disclosed as soon as practicable after the start of the meeting and the reasons given for declaring such interest.

As members are aware, the provisions of the Local Government Act restrict any member who has declared a pecuniary interest in any matter from participating in the discussion or voting on that matter, and requires that member to vacate the Chamber.

Council's Code of Conduct provides that if members have a non-pecuniary conflict of interest, the nature of the conflict must be disclosed. The Code of Conduct also provides for a number of ways in which a member may manage non pecuniary conflicts of interest.

SUPPORTING INFORMATION**Water Supply**

The much welcomed 515mm of rainfall received from 1 January through to 8 May of 2020 has already surpassed the 2019 yearly total of 480mm (as recorded at Orange Airport). This rainfall has eventually generated runoff into our storages, helping to raise our combined storage from a low of 21.1% on 14 February 2020 to 24.53% as at 8 May 2020. This latter combined storage includes 21.79% in Suma Park Dam and 36.26% in Spring Creek Dam. Between 1 January and 8 May a total of 183 ML had flowed into Suma Park Dam, with runoff from the rural catchment now responsive to rainfall.

The Orange City Council website is a great way of keeping up to date with water supply figures. The “Water Storage” tab shown in the cut and paste from the website below (<https://www.orange.nsw.gov.au/water/oranges-water-supply/>) provides weekly updates on water storage levels. The City’s water use is also updated on a weekly basis (refer the

4.1 Water Supply Update

“Water Use” tab) and as at 7 May the residential sector was using 119 litres per person per day, demonstrating the ongoing commitment to water restrictions.

Macquarie River

The NSW Government granted conditional authorisation under the *Water Supply (Critical Needs) Act 2019* to temporarily run the Macquarie River to Orange pipeline when there is a reduced flow rate in the river down to 38 megalitres a day. A copy of the authorisation can be found in the “Macquarie River to Orange pipeline” tab under the Orange City Council website cut and paste provided above. Water quality and quantity monitoring is underway, and has at least included an ecological survey round for platypus, rakali and freshwater turtles.

The Macquarie River tab also includes monthly Extraction Reports that provide daily volumes of supplementary water sources (Macquarie River, stormwater and bores) transferred to Suma Park Dam. The Review of Environmental Factors (REF) for the Blackmans Stage 2 Project is well underway. A Wetland Design Workshop was held on Tuesday 28 April 2020, where community input was sought on how the Wetland could be designed, considering social benefits of education, recreation, cultural and environmental significance. The Local Aboriginal Land Council and members of the Environmentally Concerned Citizens of Orange (ECCO) and Environmental Sustainable Community Committee (ESCC) were all engaged in this process. Engineering aspects of the work are continuing in parallel with the REF.

Council is aiming to have first draft of schematic/concept plan completed by 15 May 2020 after which it will be presented as a ‘master plan’ to then take back to the second and final community workshop.

1.3 DECLARATION OF PECUNIARY INTERESTS, SIGNIFICANT NON-PECUNIARY INTERESTS AND LESS THAN SIGNIFICANT NON-PECUNIARY INTERESTS

The provisions of Chapter 14 of the Local Government Act, 1993 (the Act) regulate the way in which Councillors and designated staff of Council conduct themselves to ensure that there is no conflict between their private interests and their public role.

The Act prescribes that where a member of Council (or a Committee of Council) has a direct or indirect financial (pecuniary) interest in a matter to be considered at a meeting of the Council (or Committee), that interest must be disclosed as soon as practicable after the start of the meeting and the reasons given for declaring such interest.

As members are aware, the provisions of the Local Government Act restrict any member who has declared a pecuniary interest in any matter from participating in the discussion or voting on that matter, and requires that member to vacate the Chamber.

Council's Code of Conduct provides that if members have a non-pecuniary conflict of interest, the nature of the conflict must be disclosed. The Code of Conduct also provides for a number of ways in which a member may manage non pecuniary conflicts of interest.

It is recommended that Committee Members now disclose any conflicts of interest in matters under consideration by the Companion Animals Community Committee at this meeting.

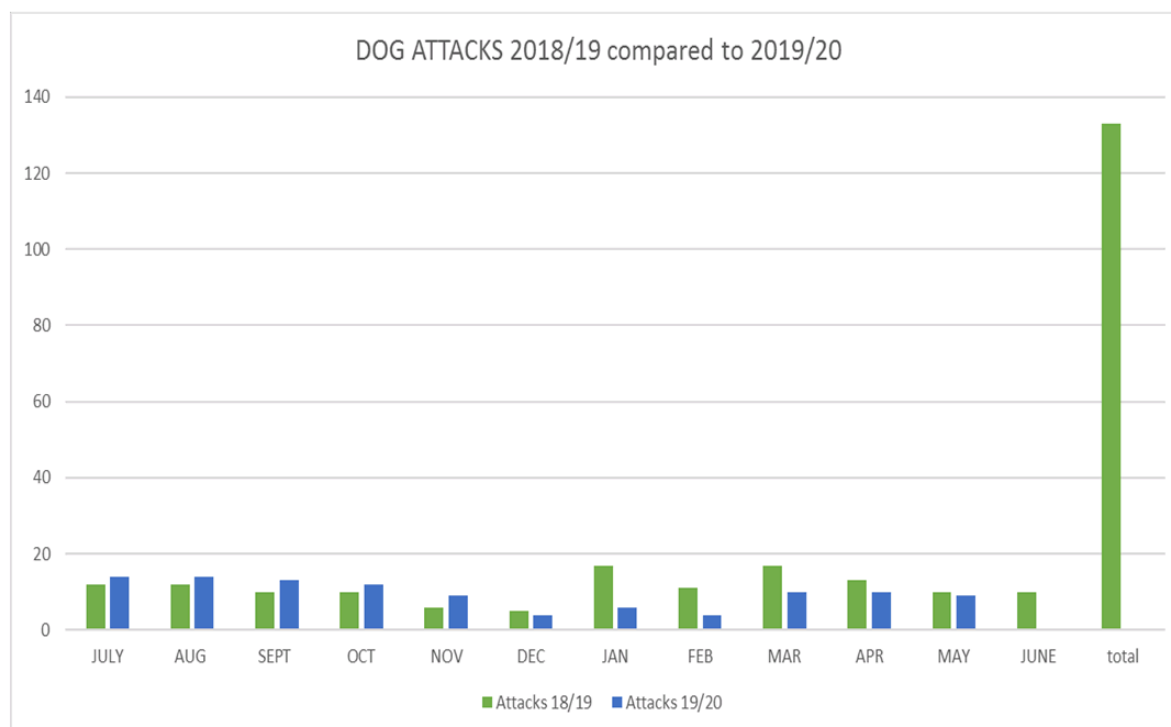
