1 INTRODUCTION

1.1 DECLARATION OF PECUNIARY INTERESTS, SIGNIFICANT NON-PECUNIARY INTERESTS AND LESS THAN SIGNIFICANT NON-PECUNIARY INTERESTS

The provisions of Chapter 14 of the Local Government Act, 1993 (the Act) regulate the way in which Councillors and designated staff of Council conduct themselves to ensure that there is no conflict between their private interests and their public role.

The Act prescribes that where a member of Council (or a Committee of Council) has a direct or indirect financial (pecuniary) interest in a matter to be considered at a meeting of the Council (or Committee), that interest must be disclosed as soon as practicable after the start of the meeting and the reasons given for declaring such interest.

As members are aware, the provisions of the Local Government Act restrict any member who has declared a pecuniary interest in any matter from participating in the discussion or voting on that matter, and requires that member to vacate the Chamber.

Council's Code of Conduct provides that if members have a non-pecuniary conflict of interest, the nature of the conflict must be disclosed. The Code of Conduct also provides for a number of ways in which a member may manage non pecuniary conflicts of interest.

SUPPORTING INFORMATION

A Small Donation application was received by Council on 11 May 2022 from Orange City Rugby Club Ltd (*Category - General Donations – Grand Finals, Carnivals/Championships and Invitations. Category maximum* \$1,000).

Central West Rugby and Orange City Rugby Club have been selected to host the Under 14's State and NSW Country Rugby Championships. To date, 25 teams have nominated to come to Orange for a three-day tournament over the June long weekend (11-13 June 2022). It is anticipated that over 1,600 people will attend this tournament with many staying in and around Orange for the three days. The organisers will set up four full-sized rugby fields, parking for 25 buses and 350 cars, and related logistics.

Orange City Rugby Club Ltd request \$500 in-kind labour from Orange City Council to line mark 4 fields. They also request to borrow 100 liner meters of safety netting, 45 star posts and 45 liner meters of metal pedestrian fence from Council.

Ben Keegan, Council's Sport and Recreation Coordinator has been consulted and indicates that this work can be done in time, after approval by Council (7 June) but before the championships (11-13 June).

The Swim NSW Conference caters to swim coaches and teachers throughout NSW. Run over two days, the conference includes guest speakers from high performance programs and specialists in swimming and related services. There will be two conference streams alternating between the Bowling Club and Aquatic Centre, providing quality education and workshops for performance coaches as well as grass-roots coaches and teachers.

Approximately 75 delegates will attend with conference, with approximately 60 being from outside of Orange and thus, staying overnight in local accommodation. Being school holidays, the organisers will promote the Orange region and the opportunity to spend a few days to explore all that it has to offer.

The conference has a total budget of \$14, 400. In addition to this grant, other income will be sourced from registrations, a NSW Regional Business Event Development Fund grant, and some private sector sponsorship.


