The provisions of Chapter 14 of the Local Government Act, 1993 (the Act) regulate the way in which Councillors and designated staff of Council conduct themselves to ensure that there is no conflict between their private interests and their public role.

The Act prescribes that where a member of Council (or a Committee of Council) has a direct or indirect financial (pecuniary) interest in a matter to be considered at a meeting of the Council (or Committee), that interest must be disclosed as soon as practicable after the start of the meeting and the reasons given for declaring such interest.

SUPPORTING INFORMATION

Following on from the previous Council term where significant investment was made in sport and recreation infrastructure, Council is continuing to identify and undertake projects to meet community needs.

The following information is provided to update the Committee on key sport and recreation projects that are currently being completed by Council.

Orange Regional Sports Precinct

In February 2022, the Western Regional Planning Panel provided Council with concept planning approval for the Orange Regional Sports Precinct. Following this approval, Council was required to seek permission from the NSW Heritage Council to commence works which was received in March 2022.

4 MAY 2022

3.1 Current Projects Report - Sport and Recreation

Since early April, contractors have been completing tree removal across the site. The fallen radiata pine trees and radiata pine grindings will be collected by a logging company to be used in timber production. The remaining timber, from native, and exotics (excluding the radiata) will be processed into mulch and utilised on site during landscaping works.

There are also approximately 10 trees that will be transplanted on site which will be completed in coming weeks.

Tenders for the extensive civil work required for the precinct are currently being assessed with a report to award the contract to be considered at a Council meeting in May. Once awarded, it is expected that contractors will be on site by the end of June with works to include the stripping and stock piling of topsoil, site levelling, installation of stormwater and drainage upgrade.

Due to the size of the site, it is expected that the civil works will take up to 12 months to complete.

The tender documentation for the design of the athletics and football stadiums is currently being finalised and will be advertised in late May to early June. This design process will also include the submission of applications for relevant approvals for the construction of the two stadiums and ancillary facilities.

Riawena Oval Picket Fence

Council has recently completed the installation of a recycled plastic picket fence at the City's No.2 Cricket venue, Riawena Oval.

Council originally allocated \$100,000 in the 2021/22 Delivery Operational Plan for the installation of a picket fence at Spring Hill Cricket Oval within the Spring Hill Recreation Ground; however, after completing the procurement process in July 2021, Council was advised by the Spring Hill Recreation Trust that they received alternative funding for the construction of a picket fence around the oval.

As the contractor had been already engaged and the fencing product ordered, Council discussed an alternative location for the installation of the picket fence.

Given Riawena Oval's high utilisation as a 1st Grade Cricket ground, dog leash free area (outside cricket season) and community recreation space, combined with the relatively poor condition of the exiting chain mesh fence, it was resolved by Council to redirect funding from the Spring Hill project to Riawena Oval.

Worth noting is that Riawena Oval is also a key venue for regular state level cricket events, so the installation of the new picket fence has greatly increased the overall presentation of the oval.

Wade Park Female Friendly Amenities and Renewable Energy Solutions

In January 2022, Council was awarded a grant for \$890,000 under the NSW Government's 2021/2022 Regional Sports Facility Fund to undertake renovations to the Wade Park changerooms located under the western grandstand and to install renewable energy and energy efficient infrastructure.

The project includes a much-needed upgrade to Wade Park's amenities and referee room to provide fit for purpose facilities that cater for increased female participation in sports such as cricket and rugby league which are regularly played at the venue.

Largely unchanged since the grandstand was constructed in the 1970's, the player and referee changerooms no longer meet required standards. Once completed the venue will have four high quality changerooms (two under the grandstand and two in the Carl Sharpe Cricket Centre) with which will allow both men's and women's teams to have their own designated changerooms.

Other upgrades included as part of the project is the installation of a 30kW solar PV system, heat pump hot water system, battery storage and energy efficient LED lighting for the precinct which is hoped will achieve a net zero outcome for the site.

Works are expected to commence in July however the project will be staged so as to limit the impact of regular Wade Park users.

3.1 Current Projects Report - Sport and Recreation

Wade Park Sound System Renewal

Council has recently awarded the contract for the renewal of the sound system at Wade Park.

The existing PA system at Wade Park is over 30 years old, with the quality of the amplifier and speakers has degraded over time. The existing speakers also have substantial noise "spill" outside the venue and it is not uncommon for Council to receive noise complaints from residents a number of blocks away from Wade Park.

New stadium speaker technology provides a much higher quality of sound output whilst ensuring noise can be better contained within the venue. Installation of the new sound system will commence in May 2022 and take approximately 2 weeks to complete.

Anzac Park Additional Netball Courts

Council commenced construction of two additional outdoor netball courts at Anzac Park in October 2021 following the receipt of a \$267,000 grant under the State Government's Stronger Country Communities Fund.

Unfortunately works have been delayed considerably due to persistent rain through the spring and summer months. However the two courts are expected to be completed by the end of May 2022 (subject to weather).

The Orange Netball Association has experienced continued growth over the last 10 years and is now one of the City's highest participation sports. The additional courts will allow the Association to meet peak demand for weekly training and competitions.

Playground Projects 2021/2022

In December 2021, Council awarded contracts to supply and install four playgrounds across the City.

These projects include two new playground locations at Sullivan Reserve (Sullivan Circuit, Discovery Hill Estate) and Larance Park (corner Sunny South Crescent and Maguire Avenue) and two playground renewals at Sir Neville Howse Park and Glenroi Oval.

Installation of all four playgrounds will commence towards the end of May 2022 and be completed by the end of June 2022.

It should also be noted that the installation of the Matthew Park playground will commence on Monday, 2 May 2022. This project was scheduled for completion in 2021 however poor site conditions due to persistent rain combined with contractor availability has significantly delayed the delivery of this project.

Total cost of all five playground projects is over \$530,000.

3.1 Current Projects Report - Sport and Recreation

Sir Jack Brabham Park - Additional amenities

In February 2022, Council received \$494,000 through the State Government's Stronger Country Communities Fund to construct an amenities block to complement the recently refurbished amenities on the eastern side of Sir Jack Brabham Park.

The new amenities building will include two female changerooms, accessible toilet and referees changeroom.

A major aim of the project is to provide facilities that cater for the growing participation of females in traditionally male dominated sports and for people with disabilities. This new facility will provide a safe inclusive environment where women, girls and people with a disability can play in competition games through fit-for-purpose facilities.

Glenroi Oval Master Plan

Following the development of the Glenroi Oval Master Plan in August 2020, Council has allocated \$100,000 to replace the two asphalt basketball courts located in the central part Glenroi Oval, off Maxwell Avenue.

The new courts will be constructed from concrete to reduce the likelihood of damage from vandalism and will be reoriented north/south to improve playability.

Council will also engage a suitably qualified skate park design company in the near future to develop plans for the extension of the Glenroi Oval Skate Park.

Spring Hill Basketball Court

Council has recently completed the construction of a new half basketball court at Alf Reed Park, Spring Hill.

The old asphalt basketball court was in relatively poor condition and small in size so the new court was made larger and constructed from concrete to improve playability and increase the life expectancy of the court.

A new basketball backboard system was also installed as part of the project which cost a total of \$25,000 to complete.
