1 INTRODUCTION

1.1 DECLARATION OF PECUNIARY INTERESTS, SIGNIFICANT NON-PECUNIARY INTERESTS AND LESS THAN SIGNIFICANT NON-PECUNIARY INTERESTS

The provisions of Chapter 14 of the Local Government Act, 1993 (the Act) regulate the way in which Councillors and designated staff of Council conduct themselves to ensure that there is no conflict between their private interests and their public role.

The Act prescribes that where a member of Council (or a Committee of Council) has a direct or indirect financial (pecuniary) interest in a matter to be considered at a meeting of the Council (or Committee), that interest must be disclosed as soon as practicable after the start of the meeting and the reasons given for declaring such interest.

As members are aware, the provisions of the Local Government Act restrict any member who has declared a pecuniary interest in any matter from participating in the discussion or voting on that matter, and requires that member to vacate the Chamber.

Council's Code of Conduct provides that if members have a non-pecuniary conflict of interest, the nature of the conflict must be disclosed. The Code of Conduct also provides for a number of ways in which a member may manage non pecuniary conflicts of interest.

The provisions of Chapter 14 of the Local Government Act, 1993 (the Act) regulate the way in which Councillors and designated staff of Council conduct themselves to ensure that there is no conflict between their private interests and their public role.

The Act prescribes that where a member of Council (or a Committee of Council) has a direct or indirect financial (pecuniary) interest in a matter to be considered at a meeting of the Council (or Committee), that interest must be disclosed as soon as practicable after the start of the meeting and the reasons given for declaring such interest.

As members are aware, the provisions of the Local Government Act restrict any member who has declared a pecuniary interest in any matter from participating in the discussion or voting on that matter and requires that member to vacate the Chamber.

3.1 COMMUNITY COMMITTEE MEMBER UPDATES

TRIM REFERENCE: 2023/261

Anne Reith - RSPCA Movie Day was successful. Dogs Day Out at Heifer Station in February raised \$1100. The next movie night is on 18 May 2023.

Pound Officer - there are many people trying to surrender dogs to the Pound, many unwanted kittens and cats are being brought to the Pound.

Danielle Haase - We need to look at an advertising strategy.

Cr Hamling - noted the importance of people putting collars and name tags on their dogs.

Pam Davis - tags can be lost, embroidered collars are better. Bloomfield attacks not being reported to Council. Would be good to have a fenced area at Bloomfield. Need to check the CRM system to find out how many attacks have been reported. Perhaps the rangers could do a late patrol.

3.2 MAINTENANCE OF OFF LEASH AREAS

Mowing in dog exercise areas is well done in both fenced and unfenced areas.

Lombardy Way dog exercise area needs some maintenance in the areas around the seatslong grass need snipping and spraying, more tree planting is required. Direction signs need to be erected in Lombardy Way as parking is easier there than trying to get off The Escort Way.

Machin Park requires the tree canopy to be lifted approximately 2m off the ground in the eastern corner.

Response to the Action Items that were raised at the last meeting of the Companion Animals Community Committee on 2 March 2023.

3.1- That figures on dog attacks reported at Bloomfield Park be presented.

Going back to 2013 through the Customer Request Management system there were 19 attacks listed in Bloomfield Park/ Gosling Creek area. Many of these were listed as being in the Gosling Creek area where dogs are not allowed. In 2023 there has been one attack reported. In 2022 there were two attacks reported.

3.2.1- Council to enquire as to the cost of compostable dog bags in place of the current biodegradable bags.

The Council ranger's order is usually 6 cartons of bags containing 10 rolls of 200 bags. Cost is \$102.30 per carton. The cost of the compostable bags from Oh Crap is \$114.99 per carton so a very similar cost.

3.2.2 That Council include planning for Dog Exercise areas in the early stages of subdivision planning.

The new affordable housing development planned for Lone Pine Avenue has been made aware of this requirement.

3.3.2 That Council produce figures on the growth of companion animal ownership in Orange in respect to identification and registration. Figures are shown below for the last ten years.






Dog attacks

Dog attacks for February - 3 attacks, 1 human victim, 2 animal victims, 1 on private property, 2 in a public place.

Dog attacks for March – 5 attacks, 2 human victims, 8 attacking dogs on private property, 2 in a public place.

Dog attacks for April – 4 attacks involving 8 dogs, 5 human victims, 5 animal victims on a private property.



Council Ranger and Pound Activity-Dogs

February - 16 were returned home by the rangers, 32 arrived at the pound, 29 were returned to their owner, 4 transferred to rescue organisations, 2 were adopted and 1 was euthanised (unable to rehome).

March - 29 were returned home by the rangers, 34 arrived at the Pound, 33 were returned to their owner,9 transferred to rescue organisations, 2 were adopted, 14 euthanised (7 unable to rehome, 2 illness, 5 unsuitable for rehoming.

3.2 Customer request and Pound Statistics

April – 8 were returned home by the rangers, 26 dogs arrived at the Pound, 19 were returned to their owner, 4 were transferred to recue organisations, 6 were euthanised (4 unable to rehome, 1 illness, 1 dangerous)



Orange City Pound activity- Cats

February - 40 arrived at the Pound, 5 were returned to their owner, 9 were transferred to rescue organisations, 3 were adopted, 1 died, 16 were euthanised (10 due to illness, 1 feral, 5 unable to rehome)

March - 21 arrived at the Pound,13 were transferred to rescues,4 adopted, 10 unable to rehome)

April - 28 arrived at the Pound, 3 were returned to their owner, 8 were transferred to rescue organisations, 3 were adopted, 16 were euthanised (3 feral, 6 due to illness,7 unable to rehome)

Registrations

What percentage of dogs at the pound each year are registered and returned home? Approx. 25% are already registered so don't incur a fee if it is the first time in the Pound for the year, and another 34% are registered before they leave the pound to return home. The remainder of the animals need to be microchipped and registered before they leave the Pound.
