 - I. The northern area of 264 Leeds Parade, as indicated in the Orange Local Housing Strategy, is to be rezoned from E3 Productivity Support to R1 General Residential, and
 - II. Such rezoning is to exclude the area of the large dam at the southern end of the property, being approximately 100m in width, which is to remain in the E3 Productivity Support zone, and
 - III. The minimum lot size for subdivision applying to the R1 area of 264 Leeds Parade is to be reduced from 2ha to 500m2, while the land remaining in the E3 zone is to remain at 2ha, and
 - IV. That the proposed R1 area of 264 Leeds Parade shall be required to provide secondary access points to both Leeds Parade and eastward to land at Lot 1 DP 1276536 to ensure an alternate route for emergency services is available.
- 2 That, for the avoidance of doubt, Council confirm that the draft DCP for the Leeds Parade Candidate Area, which accompanies the Planning Proposal, is intended to apply to both 264 and 274 Leeds Parade.
