1 INTRODUCTION

1.1 DECLARATION OF PECUNIARY INTERESTS, SIGNIFICANT NON-PECUNIARY INTERESTS AND LESS THAN SIGNIFICANT NON-PECUNIARY INTERESTS

The provisions of Chapter 14 of the Local Government Act, 1993 (the Act) regulate the way in which Councillors and designated staff of Council conduct themselves to ensure that there is no conflict between their private interests and their public role.

The Act prescribes that where a member of Council (or a Committee of Council) has a direct or indirect financial (pecuniary) interest in a matter to be considered at a meeting of the Council (or Committee), that interest must be disclosed as soon as practicable after the start of the meeting and the reasons given for declaring such interest.

As members are aware, the provisions of the Local Government Act restrict any member who has declared a pecuniary interest in any matter from participating in the discussion or voting on that matter, and requires that member to vacate the Chamber.

Council's Code of Conduct provides that if members have a non-pecuniary conflict of interest, the nature of the conflict must be disclosed. The Code of Conduct also provides for a number of ways in which a member may manage non pecuniary conflicts of interest.

Neil Jones has received a lot of feedback from the community regarding the dog parks. Neil suggested that the Committee put together a submission for Council to consider for inclusions into new sub-divisions that they have Off-Leash Dog Parks. Neil queried whether Council even have a policy for Off-Leash Dog Parks, as each dog park is different and who is responsible in relation to establishing/funding/maintenance of the dog parks. Neil has asked for clarification. Chairperson Cr Mallard advised the Committee that there was a consultation survey for the Open Space and Recreation Strategy open now and encouraged them to complete it.

The Acting Manager Compliance advised that he has a meeting with the Manager City Presentation this afternoon and will clarify the roles of each section regarding dog parks and advise the Committee before the next meeting.

Danielle Haase attended the Country Women's Association State Conference in Wagga Wagga in May. The CWA had a very strong view on cats, with their preference being for containment and desexing. The 25/26 CWA State Executive approved the key policy – supporting 24 submissions in the Companion Animals Review.

3.4 CHAIRPERSON PRESENTATION - ENVIRONMENTAL SUSTAINABILITY POLICY COMMITTEE 6 MAY 2025

Chairperson Cr Mallard explained that this presentation will be in all meetings moving forward to update the Committee on Council meeting outcomes.

The changes to the Charter were adopted unanimously.

Chairperson Cr Mallard spoke at the Council meeting about there being only one Councillor on the Committee. Cr Marea Ruddy generously offered her time to join the Committee. She was warmly welcomed into the Committee by everyone.

With the former Manager Compliance departure, the letters discussed at the last meeting requesting other organisations to join the Committee, Department of Primary Industries and RSPCA had not been completed. The Acting Manager Compliance will draft a letter for Chairperson Cr Mallard to these organisations asking for some representation on the Committee.

Chairperson Cr Mallard advised the Committee that the RSPCA will be closing from 12 June 2025. The RSPCA will be meeting with Council on 20 June 2025 to discuss the closure and how the RSPCA will be helping the community now they have closed.

Danielle Haase asked why the Council Pound is not run along the same lines as Bathurst Animal Rehoming Centre (BARC), as they work as both a Pound and Rehoming Organisation. Now that the RSPCA had closed, there would be no place for adopting stray/surrendered animals. There was discussion of the amount of time it takes for adoption versus sending them to a rehoming organisation. The Acting Manager Compliance will contact neighbouring Councils about their pound facility scope and services offered (stray/seized only or welfare matters as well).




