# 1.4 DECLARATION OF PECUNIARY INTERESTS, SIGNIFICANT NON-PECUNIARY INTERESTS AND LESS THAN SIGNIFICANT NON-PECUNIARY INTERESTS

The provisions of Chapter 14 of the Local Government Act, 1993 (the Act) regulate the way in which Councillors and designated staff of Council conduct themselves to ensure that there is no conflict between their private interests and their public role.

The Act prescribes that where a member of Council (or a Committee of Council) has a direct or indirect financial (pecuniary) interest in a matter to be considered at a meeting of the Council (or Committee), that interest must be disclosed as soon as practicable after the start of the meeting and the reasons given for declaring such interest.

As members are aware, the provisions of the Local Government Act restrict any member who has declared a pecuniary interest in any matter from participating in the discussion or voting on that matter, and requires that member to vacate the Chamber.

Council's Code of Conduct provides that if members have a non-pecuniary conflict of interest, the nature of the conflict must be disclosed. The Code of Conduct also provides for a number of ways in which a member may manage non pecuniary conflicts of interest.

It is recommended that Councillors now disclose any conflicts of interest in matters under consideration by the Council at this meeting.

Cr Judge noted that the tenders for the sport precinct were put out with a period of extension due to the Heritage NSW assessment delay and asked how long that extension period is.

The Director Community, Recreation & Cultural Services advised that the extension period will be as short as possible, though the expected time depends on the significance of the requirements given by Heritage NSW. Tenders will not be closed until Council has obtained the general terms of approval.

Cr Mallard asked there was any indication of what will be changing or modified in reference to landscaping, master plans, bushfire protection and the density of planting.

The Director Community, Recreation & Cultural Services advised that it was not as significant as first thought. Staff have met with bushfire consultant and landscaping consultants, architects and Heritage NSW to ensure compliance with the bushfire requirements that leaves as little impact as possible on the landscape design.

#### **STAFF COMMENT**

Information on the Sport NSW web reference above quotes "Pride in Sport is Australia's first and only not-for-profit sporting inclusion program specifically designed to assist sporting organisations and clubs at all levels with the inclusion of people with diverse sexualities and genders".

It is unclear to staff how the program would be implemented by Council as Council is not a sporting organisation.

Council is a member of Diversity Council of Australia which provides resources, training and advisory services specific for entities such as Council at a cost of \$4,900 per annum. This support also allows Council access to resources to help Council support services and facilities provided to the Community.

#### FINANCIAL/RESOURCING IMPLICATIONS

There is no budget allocation for membership for the Pride in Sport program. Council would need to consider adding this expense at its next quarterly review process and would either need to increase the operating deficit of Council or forego another activity.

#### 4.2 NOTICE OF MOTION - PARKOUR DESIGN

I, CR TAMMY GREENHALGH wish to move the following Notice of Motion at the Council Meeting of 2 September 2025:

#### **MOTION**

#### That Council resolves:

- 1 To reaffirm its commitment to establishing a Parkour Park in Orange, as resolved by Council on 7 November 2023.
- 2 To consider the allocation of \$7,500 in the next quarterly budget review to engage a designer to prepare the design for a Parkour Park in Orange.
- 3 To note the total estimated project cost of approximately \$300,000, including soft-fall requirements.
- 4 To Consider including the estimated cost of \$300,000 in Council's budget at the next quarterly budget review to enable delivery of the Parkour Park within the current Council term and to maximise Council's ability to apply for external grant funding.

#### **BACKGROUND**

On 7 November 2023, Council passed my Notice of Motion to undertake a feasibility study into the design, costings, and grant opportunities for the development of a Parkour Park in Orange, to be located at the old netball courts or another suitable site.

That feasibility work has now been completed, and it is important that Council takes the next step to progress this project within the current term. To move forward, we require a professional design.

At present, there is no budget allocation for this design. Completion of the design will ensure that Council is "grant ready" and in a position to leverage State and Federal funding opportunities.

The total estimated build cost of the park is approximately \$300,000, largely due to the requirement for soft-fall installation under the equipment.

Parkour is a fast-growing sport worldwide and has already been embraced by a number of councils in Australia and internationally, demonstrating its community, tourism, and health benefits.

#### Examples include:

- Newcastle Parkour Park (in collaboration with Newcastle Parkour & Newcastle City Council approx. \$30,000).
- Meadowbank Park, City of Ryde (Sydney)
- Julia Reserve Youth Park, Oran Park (Camden Council, Sydney)
- Simpson Park, St Peters (Sydney)
- Bunbury Skateboard & Parkour Park (Bunbury Council, WA)
- Innes Common, Hamilton City Park (New Zealand)
- Singapore Youth Space at Jurong Gardens (334 m²)
- Centennial Park, Hamilton (New Zealand).



## 4.2 Notice of Motion - Parkour Design

These examples highlight that parkour facilities are already being delivered elsewhere, with strong uptake by young people, community groups, and event organisers. Orange has the opportunity to become a regional leader by providing the Central West's first purpose-built Parkour Park.

Establishing this facility will not only deliver a unique recreational and sporting opportunity for Orange but also provide significant community and social benefits:

#### **Benefits**

- Provide opportunity for youth in our area to participate in a growing sport no other known Parkour Park in the region
- Create a new community space and youth sports hub
- Encourage participation with no fee to entry
- Build community connections and youth engagement
- Support athlete development and pathways
- Spread interest in a fast-growing sport, including Olympic exposure
- Provide a multipurpose space for parkour, play, and social interaction
- Cater for multi-age use, encouraging intergenerational activity
- Promote health and wellbeing as a fitness hub to get people active
- · Attract visitors and generate tourism for parkour in Orange
- Establish a potential competition venue for future events.

Delivering this project within this term of Council is a tangible investment in youth, health, and community building for the City of Orange and aligns with our community strategic plan.

#### **SUPPORTING INFORMATION**

The Mayor, Deputy Mayor, Crs Ruddy, Duffy, McDonell and Whitton attended the 2025 ALGA National Congress in Canberra ACT. This conference is the Local Government forum in the local government sector and brings together councillors, staff, agencies and industry leaders to explore common themes and goals.

The 2025 National General Assembly (NGA) of Local Government, hosted by the Australian Local Government Association (ALGA), took place from 24 to 27 June at the National Convention Centre



in Canberra. This annual event remains the largest gathering of local government leaders in Australia, drawing over 1,000 delegates including mayors, councillors, shire presidents, and senior council staff from across the country.

The theme for this year's NGA was "National Priorities Need Local Solutions", emphasizing the critical role local governments play in addressing national challenges through community-driven initiatives. The theme resonated strongly throughout the sessions, highlighting how councils are uniquely positioned to deliver tailored solutions that reflect the needs and aspirations of their communities.

The congress featured a dynamic program of keynote speeches, panel discussions, and workshops, with contributions from federal ministers, policy experts, and thought leaders. Topics ranged from climate resilience and housing affordability to digital transformation, infrastructure funding, and First Nations partnerships. A particular focus was placed on collaborative governance, with calls for stronger partnerships between local, state, and federal governments to ensure sustainable and inclusive development.

One of the standout sessions was the Regional Cooperation and Development Forum, which explored strategies for enhancing regional connectivity, economic diversification, and service delivery in rural and remote areas. Delegates shared success stories and challenges, reinforcing the importance of regional voices in shaping national policy.

The NGA also served as a platform for policy advocacy, with councils submitting and debating resolutions aimed at influencing federal legislation and funding priorities. These resolutions covered a wide array of issues, including disaster preparedness, mental health services, transport infrastructure, and water security. The outcomes of these debates will be forwarded to relevant federal ministers for consideration, continuing ALGA's tradition of grassroots policy influence.

Networking was a key feature of the event, with structured and informal opportunities for delegates to connect, collaborate, and share insights. The exhibition hall showcased innovative products and services tailored to local government needs, from smart city technologies to sustainable construction solutions.

In addition to the formal program, the NGA celebrated the achievements of local councils through awards and recognitions, highlighting excellence in community engagement, environmental stewardship, and economic development.

The 2025 NGA reaffirmed the vital role of local government in Australia's democratic and service delivery landscape. It underscored the need for adequate funding, policy support, and recognition of councils as frontline responders to both local and national challenges. Delegates left the congress energized and equipped with new ideas, partnerships, and strategies to take back to their communities.

As the NGA concluded, ALGA reiterated its commitment to championing the interests of local government and fostering a collaborative approach to national progress—one that begins at the community level.



## **Councillor Takeaways**

#### **Mayor Mileto**

I was most impressed by the presentation by demographer Bernard Salt who argued that Australia has an obvious and impressive future when one looks at global population growth over the next decades. This global growth translates to necessary growth in agriculture and mining in Australia and translates to population, agriculture and mining demand for regional Australia.

It is virtually assured that the regions will prosper economically providing a great future for Orange. It tells me what I've always believed, that Orange is destined to be a town of 60,000 within my lifetime, but that we have a challenge ahead in providing the water and infrastructure to cater for this demand.

#### **Deputy Mayor Greenhalgh**

I recently had the privilege of attending the 2025 National General Assembly (NGA) of Local Government, along with the Regional Forum.

These gatherings provided valuable insights into emerging challenges, opportunities, and innovations for councils across Australia. Importantly, they also created opportunities to engage directly with fellow councillors, CEOs, ministers, and senior decision-makers, strengthening networks that will support collaborative advocacy for our community.

The 2025 National General Assembly (NGA) and Regional Forum were attended by over 660 & 1300 delegates respectively, including councillors, federal ministers, agency heads, and policy experts. The NGA explored four national themes: Emergency Management, Safer Roads, Housing & Community Infrastructure, and Local Government Jobs & Skills.

The Regional Forum provided a dedicated platform to examine regional challenges and opportunities. Key discussions centred on financial sustainability, the role of regional councils in national resilience, population shifts, and emerging infrastructure and workforce demands.

Attendance at both forums ensured Orange's voice was present in shaping national policy and strengthened relationships with key decision-makers.

Please find below a summary of my takeaways:

#### **Key Issues & Discussion**

## **Emergency Management – Capability & Capacity**

- Brendon Moon (NEMA): reported 751 disasters declared in 521 LGAs by May 2025, with 5,548 total declarations.
- Key framework: Prepare Respond Recover.
- Drought and heatwave should now be included as rapid-onset disasters.
- Councils stressed the need for: Anticipatory action to reduce supply chain vulnerabilities.
   Critical infrastructure investment, particularly in early warning systems. & nationally consistent but locally enabled disaster recovery arrangements.
- Mitigation funding was raised by Jason Brinton, with NEMA investing \$4.34 billion nationally; five states are now using "betterment" approaches which were strongly supported.



## Housing & Community Infrastructure, Migration & Workforce Planning

- Housing remains one of the most pressing national challenges, constrained by shortages in trades and enabling infrastructure.
- Innovative council led solutions were presented, including Affordable Housing Trusts and key worker housing projects.
- Concerns were raised over competitive grant models and lack of transparency in decisionmaking
- Housing was framed as a human right, not a privilege.
- Julian Leeser MP discussed skilled migration, regional settlement, and backlog issues in citizenship and visa approvals, emphasising the need for "sticky migrants" who settle longterm in regional areas.

#### **Financial Assistance Grants (FAGs)**

- Councils continued strong advocacy for FAGs to return to 1% of Commonwealth taxation revenue.
- This is essential for regional councils with small rate bases and high service delivery costs.

#### Safer Roads

- Kenn Beer presented on Vision Zero and road safety, with the goal of zero deaths and serious injuries by 2050. He stressed case-by-case validation and reducing speed limits to achieve safer outcomes.
- Road trauma rates are rising despite safety initiatives.
- Councils identified funding gaps and road infrastructure unable to cope with larger vehicles, EVs, and freight demand.
- Calls were made for greater federal-state-local coordination and tailored regional funding solutions.

## **Local Government Jobs & Skills**

- Workforce shortages are acute in planning, engineering, health, and aged care.
- Panellists pointed to solutions such as skilled migration, cadetships, and micro-credentialing.
- Childcare access and housing availability remain key barriers to workforce attraction in regional areas.

#### National Broadband Network (NBN) - Gavin Williams

- Announced plans to extend fibre to 95% of premises by 2030.
- Current average of 25 devices per home is expected to increase to 60 by the next decade.
- Commitment to deliver faster, more reliable, and more resilient internet to regional areas, equal to metropolitan standards.

#### **Driving Efficiency Through Technology**

- Speaker: Mathew Szymczak emphasised the importance of using AI and data to deliver services more efficiently.
- Councils must ask: what level of investment are we making in this space, and how are we bringing staff along on the journey?



- Case studies included productivity gains of up to 34% through digital planning tools, highlighting both the opportunities and risks of AI.
- The need to build public trust and conduct risk profiling was strongly reinforced.

## **Community Resilience and Disaster Preparedness**

- Dr Jackie Schirmer spoke on cumulative drought impacts and the importance of ongoing support even after rain, as recovery takes years.
- Mental health support was stressed as essential, with practical strategies such as door knocking and neighbourhood check ins.
- Calls for more effective disaster relief funding models were discussed, alongside addressing slow-onset natural disasters.

#### **Rural and Regional Health**

- Professor Jenny May delivered a compelling session on equitable access to health care, advocating for a "hub and spoke" model for regional services.
- Discussions also highlighted the lack of federal funding for local road and community infrastructure (LRCI), reinforcing the need for sustained grant programs.

#### **Local Government Sustainability**

 Sessions explored the sustainability of councils in meeting growing community demands. With local government managing 77% of Australia's road network, the call for increased road funding and fair distribution of resources.

## **Federal Advocacy and National Issues**

- ALGA President's Address reinforced the call to increase the overall size of Financial Assistance Grants (FAGs), rather than continuing disputes over distribution. Community expectations are growing, yet local government funding has not kept pace.
- Minister Kristy McBain highlighted national challenges including net zero, childcare, housing supply, and disaster resilience, calling for local government sustainability and innovation in solutions.
- Shadow Minister Anne Webster reinforced bipartisan support for stronger disaster preparedness and rural resilience measures.

#### **Regional Forum**

The Forum explored "National Priorities, Local Solutions" and brought regional voices directly to the table.

#### Key themes included:

- Driving efficiency through technology to improve local service delivery.
- Better mental health in regional communities and stronger social cohesion.
- Unpaid council rates in both metro and regional LGAs are a growing issue.
- Drought and resilience were highlighted as ongoing national challenges requiring locally led approaches.
- Population growth and demographic shifts:
  - Bernard Salt (Demographics Group) identified a 25% increase in population driving demand for Australian resources.



- Predicted growth of 4 million people by 2035, with one-third of that growth being migration.
- Noted "youthification of the regions" a shift of young people (15–35) moving to regions, supported by remote work and lifestyle changes.
- Kirsty Watts highlighted growth in towns such as Orange, Dubbo, and Tamworth.
- Key industries expected to expand over the next 20 years include aged care, disability services, regional nursing, and trades.

## **Networking Benefits**

The NGA and Regional Forum reinforced the importance of relationship-building. Councillors had the opportunity to:

- Share solutions with colleagues from across Australia.
- Strengthen ties with agency leaders including NEMA and NBN Co, Australia Post and many other exhibitors in the exhibition hall.
- Advocate directly to ministers and senior officials on regional priorities.

Networking was consistently acknowledged as one of the most valuable outcomes: "You cannot put a price on networking."

## **Conclusion**

The NGA and Regional Forum reinforced that while local governments face mounting challenges—funding shortfalls, housing pressures, workforce shortages, climate resilience, and community expectations—there is also enormous opportunity through innovation, collaboration, and stronger advocacy. By participating, I was able to ensure our council's voice is part of these national conversations while also building networks that will directly benefit our community moving forward.

For Orange City Council, attendance provided:

- · Insights into emerging policy directions.
- Firsthand access to national leaders and decision-makers.
- Stronger advocacy networks to progress the needs of our community.

It is recommended that Council acknowledge the importance of continued participation in national and regional forums to strengthen advocacy, build networks with councillors, CEOs and Ministers, to ensure Orange City Council remains informed and engaged on emerging policy, funding, and governance issues. It is also recommended that Council support the ongoing sharing of insights and learnings from these events to guide strategic decision-making and enhance Council's advocacy on behalf of the community.

## Cr Ruddy

Attending the 2025 National General Assembly reinforced just how vital local government is in driving national outcomes. From housing affordability to infrastructure planning, councils like Orange aren't just implementing policies, we're solving real problems at a community level. The theme National Priorities Need Local Solutions couldn't have been more relevant. Discussions around climate action, digital transformation, and sustainable funding weren't theoretical, they reflected the everyday realities we're navigating in Orange.



What stood out for me is that local government is about so much more than roads, rates, and rubbish. We're shaping the social and economic future of our communities. I attended sessions focused on housing and community infrastructure, two critical areas where Orange is feeling real pressure. The message was clear: councils aren't just service providers; we're community builders. Whether it's advocating for affordable housing, creating better play spaces, or planning for population growth, we're directly influencing the quality of life for our residents.

We also heard from Jason Clarke of Minds@Work, whose keynote challenged us to shift our thinking from problem-solving to idea-generation. Too often, councils focus on fixing what's broken rather than imagining what could be possible. His insights were a prompt reminder that innovation should sit at the heart of local government decision-making.

Equally exciting was Stephen Scheeler's presentation on AI and the future of technology. He highlighted how AI isn't just something for big corporations, it's a tool councils can harness right now to improve services, streamline operations, and engage more effectively with our communities. It's exciting to think about how Orange could start exploring these innovations in the years ahead.

Ultimately, this conference reinforced the importance of collaboration. Stronger partnerships with other councils, open dialogue with federal ministers, and shared strategies across regions will be key to addressing the challenges facing Orange. It's clear that Councils aren't just part of the system, we're leading it.


#### **Cr McDonell**


There were two standouts for me from the Regional Forum. Firstly, demographer Bernard Salt provided a great presentation on the past, present and predicted demographics of regional, rural and remote Australia. Of particular relevance is the strong evidence showing growth in the regions will continue to rise and is an opportunity we as a city should be jumping at.

Bernard also introduced us to more acronyms:






Changing demographics of city vs region population growth:



The data showing which jobs are growing in regional Australia; care, sales, and construction; is particularly relevant for Orange as we have such a large healthcare workforce already. This then feeds into the urgent, ongoing need for affordable, diverse housing options for these key workers.

The second key takeaway the Regional Forum was the panel session "Driving efficiency through technology". This included a presentation from Snap Send Solve. This is a platform I'd spoken to the previous Director of Corporate and Commercial Services seeking investigation as to the possible integration with Council's existing process to improve resident/ratepayer reporting and satisfaction. This was a great reminder to restart this conversation with the current Director to see if we can benefit from such an integration.

#### Day 1 + 2 of the NGA:

Welcome to Country conducted by Selina Walker, Co-chair of the ACT Reconciliation Council, was fantastic.

Unfortunately, her message was not received or understood by two members of the Opposition who both made racist and offensive statements during their addresses – so much so that half the ALGA Board and many in the audience got up and walked out mid-speech. Subsequent media reports on this incident show that at least one of these MPs felt no remorse for her actions.

It was a great example of why it is still vital to conduct authentic Acknowledgement of Country and support Elders in conducting a Welcome to Country.

1300 delegates were in attendance, which was the highest attendance at the NGA yet.

It was a great opportunity to catch up with ALGWA members at the ALGWA trade stall and discuss measures underway to support women in local government across the country.

Several other trade stalls provided interesting information to start my own investigations as to potential use in our city.

On both days debate on conference motions was at times heated but still productive.



The ALGA Awards dinner at Parliament House was a great networking opportunity also. Councillor Ruddy and I were fortunate enough to share a table with staff from Burwood Council in Sydney who were nominated for an award for their work in the domestic violence space. Councillor Ruddy and I are currently following up with Burwood Council to seek more information about their project to see how we might be able to learn from their experience and adapt and mould their project for our own community in our work to address our domestic and family violence crisis.

On the whole, the NGA was, again, a valuable experience for me as a Councillor.

Formal Summary: Attendance at the 2025 ALGA National General Assembly Councillor Jeff Whitton – Orange City Council

I had the privilege of representing Orange City Council at the 2025 Australian Local Government Association (ALGA) National General Assembly, held in Canberra from 25–26 June 2025. My attendance commenced following my participation in key events prior to and during the summit.

 On Tuesday evening, 24 June, I attended the NSW Budget Dinner hosted by the Premier of New South Wales, where the state's economic and infrastructure priorities were outlined, including opportunities for regional councils.

## Wednesday 25 June 2025

I arrived in Canberra and joined the National General Assembly at **midday**. Highlights from Wednesday's program included:

- ALGA President Cr Matt Burnett's address, reinforcing the 2025 theme "National Priorities Need Local Solutions", highlighting the importance of local government in addressing infrastructure, climate resilience, and skills development.
  - Aligned with Orange City Council's Strategic Outcomes 3 and 4.
- **Keynote: "From Big Picture to Local Action"** by Jason Clarke, offering practical guidance for translating federal objectives into local strategies.
  - Aligned with Strategic Outcome 6.
- Participation in the **first debate on motions**, addressing regional infrastructure, disaster readiness, and housing affordability.
  - o Aligned with Strategic Outcomes 1, 2, and 3.
- That evening, I attended the **Central NSW Joint Organisation (JO) Dinner**, with Mayors and Councillors from across the Central West.
  - o Reinforcing Strategic Outcome 6: Open and collaborative leadership.



#### Thursday 26 June 2025

Thursday's program provided key insights on emerging priorities:

- **Plenary: "Adapting Together"** a focus on local government leadership in responding to climate change.
  - Aligned with Strategic Outcome 2.
- Stephen Scheeler's keynote: "Al for Society", highlighting how councils can leverage Al to improve services.
  - Aligned with Strategic Outcome 4.
- Participation in Listening Sessions on:
  - Emergency management; and
  - Housing and community infrastructure.
  - Aligned with Strategic Outcomes 1, 3, and 5.
- Attendance at the second debate on motions and the Parliament House Assembly Dinner, offering high-value policy engagement and networking.

#### **Key Takeaways for Orange City Council**

- A clear and consistent theme was the **tightening of Federal and State funding**, increasing the need for councils to innovate and collaborate.
- Critical priorities included housing, renewable energy, infrastructure investment, and opportunities for AI and digital transformation in local government.
- Regional collaboration and targeted advocacy are essential to meet future funding and service delivery challenges.

## **What This Means for Orange**

For Orange City Council, the Assembly reinforced that we are on the right track in many strategic areas—particularly in housing growth, sustainability, and innovation. However, the tightening of intergovernmental funding signals the need for continued vigilance.

To meet community needs while maintaining financial responsibility, we must:

- Prioritise projects based on long-term community benefit;
- Pursue regional partnerships to amplify advocacy and resource-sharing;
- Embrace digital and Al-driven solutions to improve efficiency; and
- Remain diligent and transparent in decision-making.

Council must continue to make smart, informed choices that balance innovation with financial sustainability, ensuring we deliver value to our community now and into the future.

I thank Orange City Council for the opportunity to attend this important national event and bring back valuable insights that will inform our planning, partnerships, and policy directions.

#### **EXECUTIVE SUMMARY**

At the Council meeting held 17 December 2024 there was a matter arising in relation to a list of Health Care Providers that provide access to abortion services.

MATTER ARISING Cr M Ruddy

Cr Ruddy asked if Council could coordinate a list of Health Care Providers (Doctors and Pharmacists) locally where people could access abortion services.

This report provides the most updated information identified by Council staff around the information and services available to the Community for abortion services.

Initial investigations by Council staff showed a lack of centralised information around pregnancy options and more specifically abortion services.



#### 5.3 Review of Abortion Services - Orange LGA

In February 2025, Manager Community Services contacted the General Manager of Orange Health Service and the Women's Health Clinical Nurse Consultant for Western NSW LHD (information which was shared through the outstanding resolutions list on 20 May 2025 Council papers).

Orange City Council has very recently been advised by Western NSW Health that there will be an augmentation of services for Women with the opening of a new service providing Family Choices and Women's Health.

Details for the service are not yet available and will be communicated when able to do so.

## **Other Information**

Family Planning Australia operates a website 'Search+" found at <u>Search+ — Find reproductive & sexual health services near you</u>. Search+ is an independent service funded by NSW Health which relies on providers and practices of reproductive and sexual health services themselves to register and update their services directly via a form on their website.

When registering, there is an option to be a public or private listing. Currently, when the postcode 2800 is entered and all abortion services are selected, the website advises there are no providers found, which is inaccurate information. Council will seek to update the information on this site to reflect the information mentioned above once details are available.

It is worth noting that this indicates that there are little to no abortion services in regional NSW with the exception of Broken Hill. However as a minimum abortion services are available across the Western NSW LHD at main Hospitals including Orange.



This will further change when the new clinic services are online across the Western NSW LHD.

The accuracy of information and how it can be accessed has been raised with NSW Health to ensure its information is both accurate and readily available through web searches.



## 5.3 Review of Abortion Services - Orange LGA

Council could play a role to help communicate this information and also update the information that is publicly available.

This information could include a list of practices providing abortion care, information could also be obtained of which ultrasound locations provide "sensitive" abortion ultrasounds. Also available could be specialised Pregnancy options counselling such as Family Planning NSW, NSW Pregnancy Choices Helpline and Children by Choice.

If such a list were to be created it could also include information on the 'morning after' pill (also referred to as 'Plan B'. This emergency contraception can be used to reduce the risk of pregnancy by stopping/delaying ovulation and is not an abortion pill. The morning after emergency contraception pill can be obtained without a prescription from a pharmacy, GP, sexual health clinic and family planning centre.
