- Review the effectiveness of AVOs as a protective measure for victims of DFV, including input from victim-survivors, BOCSAR data, DFV organisations and NSW Police Domestic Violence Officers;
- Expedite urgent reform of Condition 6 of AVOs with consideration to the NSW Department of Communities and Justice "Ways to Improve Order 6" Discussion Paper (https://hdp-au-prod-app-nsw-haveyoursay-files.s3.ap-southeast-
  - 2.amazonaws.com/2917/3749/6459/Order\_6\_Discussion\_Paper.pdf)(released September 2024 with closing date for responses early March 2025);
- Given that Section 38 (NSW Crimes (Domestic and Personal Violence Act)2007) is routinely not adhered to in cases of DFV, immediately amend the AVO form to include a mandatory section related to existing Section 38 requirements, including allowing space to provide justification for removal, or non-inclusion, of dependent children under the AVO;
- The review to cover Provisional, Interim and Final AVOs.


