- 1 Reaffirms its support for effective cat containment and acknowledges this intent in the Companion Animals Amendment (Control of Cats) Bill 2025,
- 2 Notes that this bill proposes to amend the Companion Animals Act 1998 (NSW) to include provisions requiring the containment of domestic cats to their owner's property,
- 3 Recognises that effective cat containment will:
 - a) Protect native wildlife and local biodiversity by reducing injury and death from domestic roaming cat predation,
 - b) Improve the wellbeing of domestic cats by reducing their risk of injury or death from vehicle strikes, dog attacks, ticks, poisoning, infections from cat fights and contracting diseases like feline aids virus,
 - c) Provide significant emotional and financial benefits to cat owners with their cats able to live longer, healthier lives along with the reduced risk of expensive vet bills and pet cats becoming lost, and
 - d) Minimise neighbourhood nuisance and disputes caused by free-roaming cats,
- 4 Writes to the NSW Minister for Local Government, the Shadow Minister for Local Government, the Member for Orange, and Local Government NSW (LGNSW), expressing Orange City Council's support for legislative reform to include cat containment provisions in the Companion Animals Act 1998 (NSW), and to request State funding for councils to support education, compliance and animal shelter capacity, and
- 5 Advocates through LGNSW, the Central NSW Joint Organisation, and any other relevant organisations for a state-wide approach to responsible cat ownership, including containment, education and enforcement measures.

Cr Peterson asked regarding operational plan action 4.1.8.1, why 40% of the library collection has been purchased in the last five years.

The Acting Director Community, Recreation & Cultural Services advised that it is a New South Wales Library standard to achieve 40% of library books held for less than 5 years to ensure currency of the collection.

Cr Peterson asked regarding operational plan action 5.1.2.1, how do migrants get linked into Settlement Service Programs and are they only linked to Council services.

The Acting Director Community, Recreation & Cultural Services advised that Council's Migrant Support Officer has connections to multiple networks and receives referrals from different organisations and services as well as community members.

Cr Peterson asked regarding operational plan action 5.1.7.1, that if the lifespan of the Orange Cemetery is 20 years, when do we need to start looking for a new location.

The Director Development Services confirmed there is approximately 20 years left for the cemetery, and there is one more site located nearby for possible extension. It was noted this issue will likely be addressed towards the end of this decade noting there is no urgency, as the rate of burials is not increasing with a population increase.
