1.2 Declaration of pecuniary interests, significant non-pecuniary interests and less than significant non-pecuniary interests

The provisions of Chapter 14 of the Local Government Act, 1993 (the Act) regulate the way in which Councillors and designated staff of Council conduct themselves to ensure that there is no conflict between their private interests and their public role.

The Act prescribes that where a member of Council (or a Committee of Council) has a direct or indirect financial (pecuniary) interest in a matter to be considered at a meeting of the Council (or Committee), that interest must be disclosed as soon as practicable after the start of the meeting and the reasons given for declaring such interest.

As members are aware, the provisions of the Local Government Act restrict any member who has declared a pecuniary interest in any matter from participating in the discussion or voting on that matter, and requires that member to vacate the Chamber.

Council's Code of Conduct provides that if members have a non-pecuniary conflict of interest, the nature of the conflict must be disclosed. The Code of Conduct also provides for a number of ways in which a member may manage non pecuniary conflicts of interest.

3.1 CHAIRPERSON PRESENTATION - ENVIRONMENTAL SUSTAINABILITY POLICY COMMITTEE 5 AUGUST 2025

TRIM REFERENCE: 2025/1774

There were no recorded questions or controversies arising from the Environmental Sustainability Policy Committee meeting in relation to the Minutes. It was noted Cr Duffy requested a report from staff on parking at the Lombardy Way off-leash area. The Committee formally adopted the Minutes as presented.

3.2 RSPCA OUTREACH DESEXING PROGRAM

TRIM REFERENCE: 2025/1881

Member Rosie Rowse presented an overview of a recently held RSPCA Community Day funded through the RSPCA's Outreach Program. The community day was held in July, with Committee Member Rosie Rowse's workplace, Orange Vet Hospital, being involved. The result of the day was: * 15 priority bookings for desexing, * 42 desexing of a mix of cats and dogs. Microchipping and vaccinations were done at the same time, when needed, all funded by the RSPCA. The business received positive feedback from the community, with residents returning calls. Orange Vet Hospital had a lot of new clients, including aged pensioners and low-income demographic common in the uptake. It was noted that a lot of the animals desexed showed signs of having had multiple litters of puppies and kittens. The RSPCA indicated to them that there was more funding available for the Outreach Program.

Pam Davis advised that Summer Street Vet was undertaking a cat desexing program at the moment, offering discounted rates.

3.3 POLICY ON NUMBER OF PETS ON RESIDENTIAL PROPERTY

TRIM REFERENCE: 2025/1882

Member Pam Davis presented on the number of dogs recommended to be kept on a residential property, the recommended number being 2 dogs per Council's website and questioned if that number was enforceable.

Manager Compliance clarified that the Local Government Act and EP&A Act (SEPP) cover poultry, sheep, pigs and cattle, but do not include companion animals. The Local Government Act covers those animals to address health and amenity issues, and the provisions have been in there for a long time, predating current Public Health legislation. The recommended number of dogs at a residence is a recommendation only and not enforced.

4 GENERAL REPORTS

4.1 OFF-LEASH DOG PARKS - DEVELOPMENT OF POLICY, INVENTORY AND ASSESSMENT

TRIM REFERENCE: 2025/1872

Member Neil Jones outlined his proposal to conduct an inventory and assessment of off-leash areas, with the aim of informing a recommendation to Council for the development of a policy governing their installation, maintenance, and enhancement.

RECOMMENDATION

Member N Jones/Member D Haase

That the Companion Animals Community Committee consider the proposed action and resolve to undertake the inventory and assessment of existing off-leash areas as part of their Action Plan with the view of supporting a future recommendation for the development of an off-leash areas policy.

4.2 REVIEW OF POUND FEES & CHARGES

TRIM REFERENCE: 2025/1875

Member Neil Jones provided the background and rationale for the proposal to review the current fees and charges with particular focus on surrender and adoption fees.

- He raised the question of whether surrender fees should be lowered to encourage people to surrender their animals rather than abandoning them elsewhere.
- Neil expressed support for reducing the fees and acknowledged the currently exhibited \$0 surrender fee for dogs that pose a risk to community safety.

4.3 POUND STAFFING VOLUNTEERS

TRIM REFERENCE: 2025/1878

Member Rosie Rowse spoke about the network of pledging and transport groups that assist in moving animals from pounds to rescue organisations. The Manager Compliance acknowledged that Council does utilise these services to facilitate animal transfers to rescue groups.

The Manager of Compliance outlined the current staffing situation at the pound and the associated risks of using volunteers, as detailed in the agenda. He also noted that a comparison of Council's current adoption and rehoming efforts with those of other pounds in the region will be provided in the Action Plan item.

That the Committee acknowledge the information provided by staff in consideration of the feasibility of engaging volunteers to assist with the pound's rehoming work.

- All pounds contacted take surrenders only when they have the capacity and require a fee a fee to do so.
- Pounds refer people to the RSPCA or AWL for welfare matters.
- All pounds contacted rehome animals via rehoming/rescue organisations and direct adoption.
- The animal management plans located and reviewed (publicly available on Council websites) were from Bathurst and Cowra. They both indicate:
 - *Their focus is on managing stray animals and ranger enforcement activities.
 - * Much of the content is restating legislative requirements in plain language.

3.3 COMPANION ANIMALS COMMUNITY COMMITTEE - CWA STATE CONFERENCE REVIEW

TRIM REFERENCE: 2025/980

Danielle Haase attended the Country Women's Association State Conference in Wagga Wagga in May. The CWA had a very strong view on cats, with their preference being for containment and desexing. The 25/26 CWA State Executive approved the key policy – supporting 24 submissions in the Companion Animals Review.

3.4 CHAIRPERSON PRESENTATION - ENVIRONMENTAL SUSTAINABILITY POLICY COMMITTEE 6 MAY 2025

Chairperson Cr Mallard explained that this presentation will be in all meetings moving forward to update the Committee on Council meeting outcomes.

The changes to the Charter were adopted unanimously.

Chairperson Cr Mallard spoke at the Council meeting about there being only one Councillor on the Committee. Cr Marea Ruddy generously offered her time to join the Committee. She was warmly welcomed into the Committee by everyone.

With the former Manager Compliance departure, the letters discussed at the last meeting requesting other organisations to join the Committee, Department of Primary Industries and RSPCA had not been completed. The Acting Manager Compliance will draft a letter for Chairperson Cr Mallard to these organisations asking for some representation on the Committee.

Chairperson Cr Mallard advised the Committee that the RSPCA will be closing from 12 June 2025. The RSPCA will be meeting with Council on 20 June 2025 to discuss the closure and how the RSPCA will be helping the community now they have closed.

Danielle Haase asked why the Council Pound is not run along the same lines as Bathurst Animal Rehoming Centre (BARC), as they work as both a Pound and Rehoming Organisation. Now that the RSPCA had closed, there would be no place for adopting stray/surrendered animals. There was discussion of the amount of time it takes for adoption versus sending them to a rehoming organisation. The Acting Manager Compliance will contact neighbouring Councils about their pound facility scope and services offered (stray/seized only or welfare matters as well).

ANIMAL WELFARE COMMITTEE

Findings

Finding 1 23

There is an urgent need to implement cat management strategies in New South Wales to address the overpopulation of cats in New South Wales, both in urban environments and in the wild.

Finding 2 23

Key threats to wildlife in New South Wales include not only introduced species, but also habitat destruction and fragmentation, and a holistic approach to native animals is required.

ling 3 52

Desexing programs were broadly supported by the large majority of inquiry participants, and have been proven to be an effective cat management strategy.

That not-for-profit cat rescues and volunteers have played a critical and leading role in the desexing

and rehoming of cats in New South Wales.

Educational and behaviour change programs which encourage and support people to voluntarily keep cats indoors were supported by a majority of inquiry participants, and there is some early

seep cats indoors were supported by a majority of inquiry participants, and there is some early positive evidence to support the effectiveness of such programs.

Finding 6

85

There is insufficient evidence that mandatory cat containment laws or cat curfews at a state or local government level are effective in reducing the number of free-roaming cats and therefore reducing impacts on wildlife.

Mandatory cat containment laws are likely to create equity issues and have a disproportionate impact on people from lower socio-economic backgrounds and First Nations communities.

Finding 8 86

The killing of healthy cats has a severe impact on the mental health and wellbeing of pound, shelter, veterinary and rescue staff and volunteers.

Finding 9 8

New South Wales may not be ready to adopt mandatory cat containment laws, whether these laws are statewide or at a local government level.

Finding 10 87

NSW Government and councils should manage cats in a way that supports the health and wellbeing of people, animals, and the environment.





Customer Request Statistics


