1 INTRODUCTION

1.1 DECLARATION OF PECUNIARY INTERESTS, SIGNIFICANT NON-PECUNIARY INTERESTS AND LESS THAN SIGNIFICANT NON-PECUNIARY INTERESTS

The provisions of Chapter 14 of the Local Government Act, 1993 (the Act) regulate the way in which Councillors and designated staff of Council conduct themselves to ensure that there is no conflict between their private interests and their public role.

The Act prescribes that where a member of Council (or a Committee of Council) has a direct or indirect financial (pecuniary) interest in a matter to be considered at a meeting of the Council (or Committee), that interest must be disclosed as soon as practicable after the start of the meeting and the reasons given for declaring such interest.

As members are aware, the provisions of the Local Government Act restrict any member who has declared a pecuniary interest in any matter from participating in the discussion or voting on that matter, and requires that member to vacate the Chamber.

Council's Code of Conduct provides that if members have a non-pecuniary conflict of interest, the nature of the conflict must be disclosed. The Code of Conduct also provides for a number of ways in which a member may manage non pecuniary conflicts of interest.

It is recommended that Committee Members now disclose any conflicts of interest in matters under consideration by the Environmental Sustainability Policy Committee at this meeting.

- 3. An extension to the fence height on adjoining properties to the North Orange Off Leash area has been completed.
- 4. An investigation of dog watering points in off leash areas and parks in Orange. All off leash areas with water services located nearby have this facility.
- 5. Update and printing of the Dog Exercise Area brochure.
- 6. Dogs must be on a lead signage for parks were produced and place in Moulder Park.

3.4 COUNCIL PROJECT UPDATES AND COUNCILLOR REQUESTS

The Council desexing program is underway. Mulberry Lane Vet Hospital is the vet for this program.

The Pound has had an increase in cats (89%) and dogs (40%) abandoned this year. These animals are usually not microchipped and no owner comes forward.

Signage is currently being produced for Orange Cemetery and Moulder Park. This will state that dogs must be on a lead in the areas defined.





8 DECEMBER 2022

Council Ranger and Pound activity - Dogs

September - 16 were returned by the Rangers, 45 arrived at the Pound, 23 were returned to the owner, 4 transferred to rescue, 1 Adopted, 4 euthanised unable to be rehomed

October - 11 were returned by the Rangers, 32 arrived at the pound, 23 were returned to owners, 3 transferred to rescue organisations, 3 adopted and 12 euthanised (6 unsuitable for rehoming, 2 unable to rehome, 2 due to illness, 2 at owners request)

November - 16 were returned by the rangers, 49 arrived at the pound, 21 were returned to owners, 5 transferred to rescue organisations, 3 adopted, 4 euthanised (2 unsuitable for rehoming, 2 unable to rehome)

Orange City Pound activity - Cats

September - 8 arrived at the Pound, 2 was returned to the owner, 2 euthanised (infant 1), 4 were adopted and 3 transferred to rescue

October - 15 arrived at the pound, 3 returned to owners, 3 transferred to rescue organisations, 4 adopted, 4 euthanised (unable to rehome)

November - 38 arrived at the pound, 4 returned to owners, 11 transferred to rescue organisations, 1 adopted, 7 euthanised (1 unable to rehome, 6 were feral cats.)
