1 INTRODUCTION

1.1 DECLARATION OF PECUNIARY INTERESTS, SIGNIFICANT NON-PECUNIARY INTERESTS AND LESS THAN SIGNIFICANT NON-PECUNIARY INTERESTS

The provisions of Chapter 14 of the Local Government Act, 1993 (the Act) regulate the way in which Councillors and designated staff of Council conduct themselves to ensure that there is no conflict between their private interests and their public role.

The Act prescribes that where a member of Council (or a Committee of Council) has a direct or indirect financial (pecuniary) interest in a matter to be considered at a meeting of the Council (or Committee), that interest must be disclosed as soon as practicable after the start of the meeting and the reasons given for declaring such interest.

As members are aware, the provisions of the Local Government Act restrict any member who has declared a pecuniary interest in any matter from participating in the discussion or voting on that matter, and requires that member to vacate the Chamber.

Council's Code of Conduct provides that if members have a non-pecuniary conflict of interest, the nature of the conflict must be disclosed. The Code of Conduct also provides for a number of ways in which a member may manage non pecuniary conflicts of interest.

It is recommended that Committee Members now disclose any conflicts of interest in matters under consideration by the Infrastructure Policy Committee at this meeting.



EXECUTIVE SUMMARY

Council is in receipt of a community request to alter the parking angle in McLachlan Street, between Bathurst Road and Warrendine Street, from parallel to 45° angle rear to kerb.

The request cites that the width of the street supports angle parking, the street trees making parallel parking awkward, and the lack of available parking in some sections of this area.

SUPPORTING INFORMATION

Council Parking Enforcement received several complaints about 2 vehicles in this area habitually parking at a 45° angle nose in, and also often obstructing a driveway. An Officer patrolled the area and issued Warning Notices to these 2 vehicles.

As the complaint concerned not parking at the correct angle – several other vehicles parked incorrectly in the area were issued with Warning Notices to ensure that there was no possible perception or accusation of discrimination or favouritism.

Council subsequently received an email that, among other things, requested that the parking angle be altered in the area (see attachment 2).

3.3 McLachlan St - Parking Angle Prescription Change

A community consultation letter was sent to each property in the affected area, requesting feedback on the proposal to change the parking angle prescription. Two responses were received (see attachment 3 and attachment 4).

Feedback contained in Attachment 3 was fully supportive of the proposed changes. The feedback in attachment 4 prompted an adjustment of the proposal to retain 2 (already linemarked) parallel spaces on the approach to the Bathurst Rd intersection travelling north, on the grounds of safety. This area is where traffic begins to diverge into 2 lanes depending on the direction they wish to turn at the upcoming intersection.

Dear Council.

I refer to the recent infringement number: (Redacted) which was placed in my mailbox on 24.11.2022. I am aware that I am not required to pay this fine.

The offence was parking in a 45 ° angle where it is not sign posted to do so.

I would like to point out that it is very common in this street for people to park at this angle. This is also happening in the streets around the area. There are reasons for it.

Firstly, I have recently moved here and I did neglect to look for signs because everyone else was parking at the 45 $\,^{\circ}$ angle and it being logical and common in this city, I just copied.

Your parking officer only comes during working hours – Monday to Friday – 9-5, but a lot of the residents also work so they always park there at 45 $\,^{\circ}$ after hours, not even imagining that they have committed an offence. [You are discriminating against residents who do not drive to work, or have different working hours.]

Many of the streets in very close proximity have 45 * parking and the conditions are similar to this street. There are many other people parking at the 45 * angle, totally oblivious to the fact that they are breaking the law. One resident went into shock when I showed him my fine and said he had been parking like that out the front of his house for 40 years.

These conditions include a very graded road because of high rain occurrences.

Also, there are trees planted on the road itself, severely limiting parking opportunities. In these days of changed conditions since the road was first constructed, the situation needs to be reassessed. In days gone by, houses only had one family and probably one family car. Nowadays, separate rooms are being rented out and there could be four or more unrelated people sharing a house and because of the trees, only one available park out the front of the house.

The council has been informed of the blockage in the drains in this street, but has chosen not to address the situation, so when it rains heavily, the gutters fill up fast and water is forced up and in some instances can come up to the front steps of people's homes. My next door neighbour has had the rain up to the front steps of her house and her car was going under, the water level was about two inches above the interior car floor. Are council going to pay for car damage including electrical?

There have been instances where residents have been forced outside in very dark night in the pouring rain to move their cars to another block or another street because the threat of such water damage to their vehicles has been imminent. Then they have to walk home in the rain. Ridiculous. Then they can worry that the new parking spot is also being flooded, but it's too far for them to keep an eye on.

The problem is further exacerbated if the person is disabled, ill, aged or infirm. It also poses a danger to self if the person is attacked while walking the streets at night. Another problem here is that this street is not very well lit.

Putting large trees [under power lines] actually on the road may have looked cute a hundred years ago, but it is very impractical now considering the changing demographics. Also, the trees are so large now that the root systems are protruding out of the ground, further reducing parking spaces.

The archaic rule of parking parallel to the gutter puts added stress on the aged residents in this street because of the fear of damage to their car and subsequent loss of transport and financial hardship incurred by rain in the deep gutters, coupled with the possibility of not even getting a park out the front of their own residence because neighbours may be parking there and then they have fear of a fall because they are walking extra distance, possibly in bad weather and/or lighting conditions. The serious OH &S risks here require for this situation to be addressed.

The street is very wide and especially with the trees there, parking at 45 ° angle is not taking up any extra space on the road or impeding the traffic in any way.

When it is so obvious that common sense has prevailed and a lot of people are doing something practical in a safe way, instead of clamping down on the letter of the law, perhaps it's time to consider the demand for parking spaces and the need to keep the engine and interior of cars dry and especially with the changing weather climate and reallocate the parking requirements to reflect the practical and safer needs of the community that you serve.

The need for a parking compliance officer in this area would be eliminated and the saved money could be used to repair the potholes in this quite busy street. When it rains a lot, you can't see where they are.

There is currently no prescribed parking angle, and as such parallel parking applies, however, the majority of vehicles park at a 45° angle. The parallel parking has not been enforced by the Parking Enforcement team.

The Engineering Services Design Team, at the request of the Transport Asset Engineer, undertook a design for the delineation of parking. This was done in conjunction with discussions with the businesses along this length of road to determine any concerns or requests, predominately the inclusion of No Stopping zones around driveways for accessibility and visibility. The design is compliant to the parking requirements in AS2890.5 – On Street Parking.

That Council alter the parking angle prescription in William Street as shown in Figure A, between March Street and Dalton Street.

FURTHER CONSIDERATIONS

Consideration has been given to the recommendation's impact on Council's service delivery; image and reputation; political; environmental; health and safety; employees; stakeholders and project management; and no further implications or risks have been identified.

SUPPORTING INFORMATION

This length of road is a fairly busy area, with significant movement of heavy vehicles through the area (such as Transgrid bucket trucks and medium/heavy rigid trucks delivering bulky goods to several businesses).

This length of road also features varying road width as the road narrows around the bridge (crossing the East Orange Creek). On either side of this bridge area the road width will support 45° angle parking - maximising the amount of parking available in the area. The road width, where it narrows for the bridge, would best support parallel parking.

This length of road does not currently have signage prescribing the parking angle. As such, parallel parking technically applies to the length of road. However, most vehicles parked on this street are usually parked at a 45° angle.

3.3 Definition of Prescribed Parking Angles - William Street (between March and Dalton Streets)

The parallel parking has not been enforced by the Parking Enforcement team previously as there have been no complaints received and no safety issues raised. This has recently changed as new businesses have entered the area and parking density has increased.

The manager at TLE (an electrical supplier) has also expressed concerns that their driveway is often unsafe to use, with vehicles angle parked close to the driveway. Currently vehicles are angle parking within a few metres of the driveway, causing visibility issues for traffic approaching from the north, as vehicles are leaving the driveway. This is anecdotally supported by a Council information counter staff member who has children attending a Jiu Jitsu gym at the rear of this premises (sharing a common driveway). A "No Stopping" zone for the driveway, which extends 10m north of their driveway, should alleviate this concern. This driveway is easily the most used in the area and the only one considered 'high risk' enough to require a "No Stopping" safety buffer.

The mechanic business across the road (EWS Mechanical), has expressed confusion as to how vehicles should be parked, and also indicated a need for angle parking in the area to ensure sufficient parking for staff and customer vehicles.



At the Council Meeting held on 6 September 2022, a report regarding the Lords Place South Concept Design was considered and Council resolved that it be exhibited for 21 days.

Following the 21 day exhibition period, a report was considered at the Council Meeting held on 18 October 2022, where Council resolved to adopt and implement the recommendations of the GHD Parking Study. One of the GHD recommendations was the line marking of the car parking spaces on adjacent streets to increase parking yield. By changing the prescribed parking angle from 45 degree to 60 degree, there is an increase in total number of parking spaces.

The recommendation in this report relates to the Delivery/Operational Plan strategy "9.2. Ensure that adequate car parking spaces are available to support growth".

The Engineering Services Design Team undertook a site survey and completed a design for the on-street parking spaces compliant with AS2890.5 – On-Street Parking. As an option to increase the availability of parking further, changing from 45 degree to 60 degree parking spaces was assessed. This further increased the number of parking spaces on all the blocks mentioned above.

To line mark the car park spaces at 60 degrees, updating and replacing all 45 degree signage is required.





EXECUTIVE SUMMARY

The purpose of this report is to update Council on construction and maintenance works which have been carried out since the last current works report to Council.

SUPPORTING INFORMATION

Road Maintenance

Crews continue to undertake pothole patching activities across the city in response to customer requests and inspections.

Road Upgrading

Forest Road

Works by Council staff on the upgrading of Forest Road, east of Gander Road, have progressed well and the first stage of the project has now been sealed. The second stage is expected to be completed within the next two weeks. The works will generally widen the sealed surface and improve the road geometry, whilst making improvements to the road pavement structure. New guardrail will also be installed to improve safety outcomes.

The upgrading works are being co-funded by Transport for NSW under their Regional Road Repair Program.

Huntley Road

Council's contractors have completed and sealed a 1.6km section of road rehabilitation of Huntley Road. The rehabilitation works included minor widening and pavement strengthening through the incorporation of cementitious binding agents. Works on Huntley Road were co-funded by the Federal Government under the Roads to Recovery Programme.

Dalton and Peisley Roundabout

Council's contractors undertook works to reconstruct the pavement at the Dalton and Peisley Street roundabout with hot-mix asphalt. Works were undertaken at night to avoid traffic disruption at this critical intersection adjacent to the rail level crossing.

Concrete and Drainage

Footpaths

Work has commenced or continued on new footpaths and footpath reconstructions at:

- Edward Street from Electrolux to McNeilly Avenue (fully funded through TfNSW "Get NSW Active" grant programme).
- Path into the rear of the Christian School (fully funded through TfNSW "Safety Around Schools' grant programme).

Works have been completed on new footpaths or footpath reconstructions at:

- Shared concrete path under the NDR at Ploughmans Creek heading to Molong Road alongside the Fire Shed.
- Dalton Street, between Peisley Street and Lords Place.

Blue Seats

Traffic Facilities

Works continue on the construction of a new roundabout at the intersection of Dalton and Clinton streets. Watermain relocations have been completed and new stormwater drainage infrastructure installation is being finalised. Excavation of the existing pavement has been undertaken to allow for the construction of the centre concrete ring and the new road pavement.




The Decision Support Tool (DST) quarterly review was conducted 16 January 2023 with neutral conditions predicted from the POAMA forecast. Additionally, as storages remain above 90% capacity, there are no changes to operating conditions. The next quarterly review is scheduled for April.

Macquarie River Flows

The mean daily flows in the Macquarie River monitored downstream of Long Point (Station 421192) for the period 22 February to 21 March 2023 are presented below. On 15 March 2023 flows reduced to below the extraction trigger value of 108 ML/d for the first time since March 2021. Flows remained below the trigger with a minimum daily flow rate of approximately 74 ML/d on 17 March 2023. A maximum daily flow rate of approx. 445 ML/day was recorded on 27 February 2023.


Residential water use

Permanent Water Saving Standards came into effect on Friday 25 June 2021.

Average daily residential water consumption for the period 17 February 2023 to 16 March 2023 was 179 litres per person per day.

The average daily city-wide water consumption for the period 17 February 2023 to 16 March 2023 was 11.55 ML/day.

DRINKING WATER QUALITY

Water samples are collected as a component of Orange City Council's Drinking Water Quality Monitoring Program in accordance with NSW Health requirements. Samples are collected regularly and sent to the NSW Government National Association of Testing Authorities (NATA) accredited laboratory for analysis. Water quality for February 2023 complied with the Australian Drinking Water Guidelines health targets.

OTHER MAJOR PROJECTS

Lake Canobolas Water and Sewer

Construction has progressed from the Lake to the intersection of Mt Pleasant Lane and Canobolas Road. Rock has delayed the contractor's creek under-bore through the private land adjacent to the dear park. Council is liaising with the contractor on the most effective way to move forward in this area.

The current date for Practical Completion is 8 July 2023.

East Orange Harvesting Wetlands (Blackman's Swamp Creek Stormwater Harvesting Stage 2)

This project, which is designed to provide an offline storage on Blackman's Swamp Creek to increase the city's water supply secure yield, had been experiencing a delay due to a refusal of Council's Water Supply Works Approval (under the Water Management Act 2000) application by the Natural Resources Access Regulator (NRAR).

This refusal predominantly revolved around the interpretation of a weir and its legality under the Water Sharing Plan for the Macquarie-Bogan Unregulated Water Sources 2012 as it was deemed to be an in-river dam and not permitted.

Following the amendments to the Water Sharing Plan for the Macquarie-Bogan Unregulated Water Sources 2012 to exclude a water supply work to be used for town water supply purposes by a local water utility, Council has now made a new application to DPE for a Water Supply Works Approval. Council understands that the exhibition period for this project closed on 31 January 2023 and we are awaiting an approval.

Sewage Treatment Plant Inlet Works

This project involves upgrading the existing inlet works at the Orange Sewage Treatment Plant (STP) to meet the peak wet weather flow demand and replace the old inlet system with improved screening and improved contingency measures. The proposed works involve excavation of the construction area, relocation of two inlet sewer pipelines, water main and internal STP access road, and installation of a retaining wall adjacent to the new inlet works. New inlet work structures include screening channels, grit trap, pump station and flow splitter, and associated connection piping, electrical cabling, screens, grit trap, washing equipment and pumps.

3.1 Current Works

Precision Civil Infrastructure Pty Ltd established on site in December 2022 and to date have completed the realignment of watermains to facilitate the construction of the retaining wall required to provide space for construction works.

Some delays have been experienced with the project determining an appropriate method to ensure the large excavation is safe and in the removal of a significant quantity of unanticipated rock.

The current date for Practical Completion is 28 November 2023.

Future City – Lords Place South

Significant effort is being made to ensure the majority of works are completed by Easter.

Six of the eight proposed decks are in place with a further deck to be installed in the next week.

This Thursday and Friday (23rd and 24th March) street under-bores will be occurring for the water main upgrades; this will be followed by a road crossing on Sunday 26 March 2023 and further excavations to make the water main live in the following week.

Subject to weather, painting of the street is programmed to commence during the week beginning 27 March 2023 and street furniture installed in the week leading up to Easter.

Within the next fortnight it is anticipated the white way lighting poles will arrive and be installed. The luminaires are still to arrive.



These figures include passenger numbers from Regional Express, Link Airways (formerly Fly Corporate) and QantasLink.


